This MEMORANDUM OF OPTION AND EASEMENT AGREEMENT is made this day of _______ 1999, between Crown Pacific Limited Partnership, a Delaware limited partnership("Grantor"), and AT&T Wireless Services of Washington Inc., d/b/a AT&T Wireless Services, a Oregon Corporation ("Grantee").

AGREEMENT

- 1. Grantor hereby grants to Grantee an Easement over a portion of the real property located in the County of Skagit, State of Washington, and more particularly described in Exhibit A attached hereto and incorporated herein by this reference (the "Property"). The portion of the Property containing the Easement granted to Grantee is described and depicted in Exhibit B attached hereto and incorporated herein by reference (the "Project Area").
- 2. The easement agreement is more fully set forth in the Option and Easement Agreement between Grantor and Grantee, dated July 23,1999 (the "Easement"), the terms of which are incorporated herein by reference.
- 3. The Easement shall be for an initial term of five (5) years, and five (5) subsequent optional extension terms of five (5) years each, pursuant to the terms of the Easement.

- 4. The Easement provides for access and utility easements over the Property during the term of the Easement, as described in the Easement.
- 5. This Agreement is executed for recording purposes only and is not intended to be a summary of the Easement, and is subject to the terms of the Easement. In the event of conflict between this Memorandum and the Easement, the Easement shall control.
- 6. This Agreement shall inure to the benefit of and be binding upon Grantor and Grantee and their respective representatives, successors and assigns.


