THEREFORE, FNB does hereby authorize and empower the Officers, in FNB's name, place and stead to do the following in connection with the sale and transfer of substantially all of the assets of FNB's corporate trust business sold to State Street pursuant to the Agreement for Acquisition of Corporate Trust Business dated April 2, 1997 (the "Acquisition Agreement"), and including, without limitation, any and all of the corporate trust business sold to State Street consisting of transactions in which FNB has been granted title to or a security interest in real property, fixtures and equipment, goods, rights and accounts (such assets hereinafter referred to as the "Corporate Trust Accounts"):
