Agreement for Boundary Line Adjustment

This agreement for boundary line adjustment is made by and between Carl P. Sorensen & Margo Sorensen and the Estate of Carl F. Sorensen this 14th day of February, 2000.

A portion of the Northeast 1/4 of the Northwest 1/4 of Section 20, Township 35 North, Range 5 East, WM, more particularly described as follows: Beginning at the Southwest corner of the Northeast 1/4 of the Northwest 1/4 of Section 20; thence north along the east line of the Northeast 1/4 of the Northwest 1/4 of Section 20 approximately 230 feet to the existing fence line; thence South 47 degrees East along the existing fence line approximately 320 feet to the intersection of the right-of-way with Minkler Road and the south line of the Northeast 1/4 of the Northwest 1/4 of Section 20; thence west along the south line of the Northeast 1/4 of the Northwest 1/4 of Section 20 approximately 225 feet back to the point of beginning; all situate in Skagit County, Washington.




