Said Deed of Trust was executed to secure, together with other undertakings, the payment of one promissory note in the sum of \$175,000.00, with interest thereon, according to the terms thereof, in favor of Nathan J. Schmidt and Rose N. Schmidt, husband and wife, and to secure any other sums of money which might become due and payable under the terms of said Deed of Trust.
- 3. The above described Deed of Trust provides that the real property conveyed therein is not used principally for agricultural purposes.
- 4. Default having occurred in the obligations secured and/or covenants of the Grantor, as set forth in the Notice of Trustee's Sale described below, which by the terms of the Deed of Trust make operative the power to sell, the thirty-day advance Notice of Default was transmitted to the Grantor, or his successor in interest, and a copy of said Notice was served or posted in accordance with law.
- 5. Nathan J. Schmidt and Rose N. Schmidt, husband and wife, being then the holder of the indebtedness secured by said Deed of Trust, delivered to said Trustee a written request directing said Trustee or his authorized agent to sell the described property in accordance with law and the terms of said Deed of Trust.

The defaults specified in the Notice of Default not having been cured, the Trustee, in compliance with the terms of said Deed of Trust, executed and on February 9, 2000, recorded in the office of the Auditor of Skagit County, Washington, a Second Amended Notice of Trustee's Sale of said property as Auditor's File No. 200002090076. The first scheduled sale date of January 7, 2000, under the first Notice of Trustee's Sale, recorded under Auditor's File No. 199910050006, was stayed by a filing of bankruptcy petition by Donna Wiesenburger, one of the grantors under said deed of trust, under Case Number 99-11495. The discharge of the debtor under that bankruptcy proceeding was entered January 26, 2000.
- 7. The Trustee, in its aforesaid Second Amended Notice of Trustee's Sale, fixed the place of the sale as the main entrance to the Skagit County Courthouse, located at 205. West Kincaid Street, Mount Vernon, Washington, a public place, at 10:00 O'Clock A.M., on Friday, March 17, 2000, and in accordance with law caused copies of the statutory Notice of Trustee's Sale to be transmitted by mail to all persons entitled thereto and either posted or served prior to 45 days before the sale scheduled following the discharge from bankruptcy; further, the Trustee caused a copy of said Notice of Trustee's Sale to be published once between the thirty-fifth and twenty-eighth day before the date of sale, and once between the fourteenth and seventh day before the date of sale, and further, included

this Notice, which was transmitted to or served upon Grantor or his successor in interest, a Notice of Foreclosure in substantially the statutory form.

- 8. During foreclosure no action was pending on an obligation secured by said Deed of Trust.
- 9. All legal requirements and all provisions of said Deed of Trust have been complied with, as to acts to be performed and notices to be given, as provided in Chapter 61.24 RCA.
- 10. The defaults specified in the Notice of Trustee's Sale not having been cured eleven days prior to the date of the Trustee's Sale and said obligation secured by said Deed of Trust remaining unpaid, on March 17, 2000, the date of sale, which was not less than 190 days from date of default in the obligation secured, the Trustee then and there sold at public auction to said Grantee, the highest bidder therefor, the property hereinabove described, for the sum of \$196,749.73, by the satisfaction in full of the obligation then secured by said Deed of Trust, together with all fees, costs and expenses as provided by statute.
