COMMUNITY PROPERTY AGREEMENT

THIS AGREEMENT, made and entered into this 27 day of January, 1966, between J. B. MILLER and MARGARET MAE MILLER, his wife of Whatcom County, Washington.

WITNESSETH: That the parties do covenant and agree with each other that all property owned by them or held in the name of either of them was acquired and is now held as their community property under the laws of Washington, or has been, or is hereby, transmuted into such community property; and they further covenant and agree that any property which either of them may hereafter acquire as separate property during their marriage shall, immediately when so acquired, be converted and deemed to be transmuted into and become their joint community property.

THEY FURTHER COVENANT AND AGREE that any and all community property, real or personal, owned or held by them at the time of the death of the first of them to die, whether any such items were originally community or separate property, shall upon such death pass to, and full title thereto shall vest in, the survivor of them, without the necessity of any administration or probate, all pursuant to Section 26.16.121, Revised Code of Washington.
