## **Subordination Agreement**

NOTICE: THIS SUBORDINATION AGREEMENT RESULTS IN YOUR SECURITY INTEREST IN THE PROPERTY BECOMING SUBJECT TO AND OF LOWER PRIORITY THAN THE LIEN OF SOME OTHER OR LATER SECURITY INSTRUMENT.

The undersigned subordinator and owner agrees as follows:

- 1. Joachim and Patricia Richter, husband and wife, referred to herein as "subordinator," is the owner and holder of a mortgage dated August 8, 1995, which is recorded in book 1468, page 191 under Auditor's File No. 9508210115 records of Skagit County.
- 2. Frank Robert Candelario and Kristina L. Candelario, husband and wife, and Partick Charles Tye and Tonya Robison Tye, husband and wife, together referred to herein as "owner," are party to an Easement Agreement dated 2-17-2000 (which is recorded under Auditor's File No. 20000105002 records of Skagit County) (which is to be recorded concurrently herewith).
- 3. Owner is the owner of Lot 4 of the real property described in the Easement Agreement identified above in paragraph 2.
- 4. In consideration of benefits to "subordinator" from "owner", receipt and sufficiency of which is hereby acknowledged the "subordinator" does hereby unconditionally subordinate the lien of his mortgage identified in Paragraph 1 above to the easement, identified in Paragraph 2 above.

- 5. "Subordinator" acknowledges that, prior to the execution hereof, he has had the opportunity to examine the Easement Agreement, and consents to and approves same.
- 6. This agreement shall be the whole and only agreement between the parties hereto with regard to the subordination of the lien or charge of the mortgage first above mentioned to the easement above referred to and shall supersede and cancel any prior agreements as to such, or any, subordination including, but not limited to, those provisions, if any, contained in the mortgage first above mentioned, which provide for the subordination of the lien or charge thereof to an easement to be thereafter executed.
- 8. The heirs, administrators, assigns and successors in interest of the "subordinator" shall be bound by this agreement. Where the word "mortgage" appears herein it shall be considered as "deed of trust", and gender and number of pronouns considered to conform to undersigned.
