described as follows:

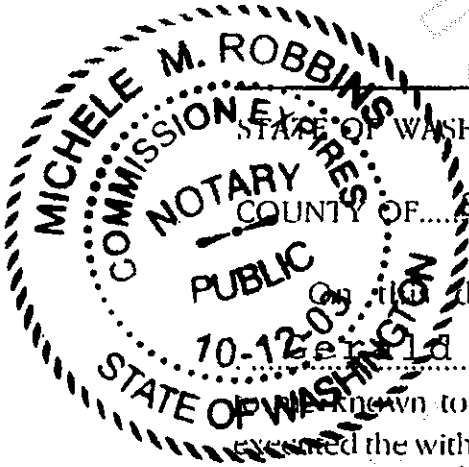
Beginning at the Southwest corner of said Lot 8,, thence
