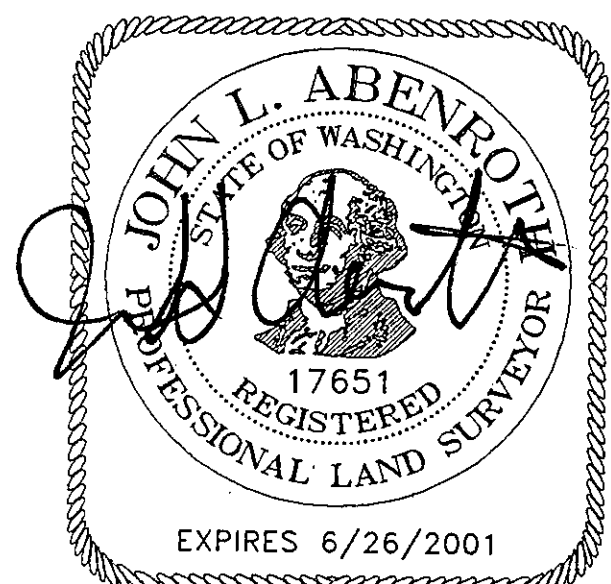
That portion of the southeast quarter of the northwest quarter of Section 11, Township 34 North, Range 4 East, W.M. described as follows:
