EXHIBIT "A"

- A. Right of the public to make necessary slopes for cuts or fills upon property herein described in the reasonable original grading of streets, avenues, alleys and roads, as dedicated in the plat.
- B. Easements shown on face of Short Plat:

An easement is hereby reserved for and granted to the City of Mount Vernon, Public Utility District No. 1, Puget Sound Power and Light Co., G.T.E., Cascade Natural Gas Co., and TCI Cablevision of Washington, Inc., and their respective successors and assigns under and upon that portion of the 30 foot private utility easement and the front 7 feet of Section Street shown hereon in which to install, lay, construct, renew, operate, maintain and remove utility systems, line, fixtures and appurtenances attached thereto, for the purpose of providing utility services to the subdivision and other property, together with the right to enter upon the lots and tracts at all times for the purposes stated, with the understanding that any grantee shall be responsible for all unnecessary damage it causes to any real property owner in the subdivision by the exercise of rights and privileges herein granted.

Private Storm Drainage Easement:

An easement for the purpose of conveying local stormwater runoff is hereby granted in favor of all abutting lot owners in the areas designated as private drainage easements established and granted herein shall be the responsibility of, the costs hereof shall be borne equally by, the present and future owners of the abutting property and their heirs, personal representatives, and assigns. The City of Mount Vernon is hereby granted the right to enter said easements for emergency purposes at its own discretion."

 - 2. Zoning R-1-13.5;
 - 3. Sewage Disposal City of Mount Vernon Sanitary Sewer System;

 - 5. All lots within this subdivision are subject to impact fees payable on issuance of a building permit.
 - 6. All maintenance and construction of private roads is the responsibility of the lot owners and the responsibility shall be shared equally by all owners based on usage;
