## AGREEMENT REGARDING SUCCESSOR DECLARANT AND INDEMNITY WESTPOINT, A CONDOMINIUM

THIS AGREEMENT is between Allegre-Mitzel Partnership, a Washington general partnership ("Declarant"), and Westside Meadows Limited Liability Company, a Washington limited liability company ("Successor Declarant").

WHEREAS, Declarant established Westpoint, a Condominium (the "Condominium") by executing and recording the Declaration for Westpoint, a Condominium, recorded under Skagit County Recording No. 200004200063 and recording the Survey Map and Plans for said condominium under Skagit County Recording No. 200004200062 (collectively, the "Condominium Documents") all in Skagit County, Washington. The legal description for the Condominium is on Exhibit A to this Agreement.

WHEREAS, Declarant has transferred and conveyed all right, title and interest in all the Units and all the Common Areas in the Condominium to Successor Declarant with the intention that Successor Declarant will substitute for Declarant in all Declarant's rights and responsibilities conferred and required by the Condominium Documents.

WHEREAS, Successor Declarant is willing to be substituted in place of Declarant and to indemnify and hold Declarant harmless on the terms and conditions of this Agreement.

NOW, THEREFORE, for and in consideration of the promises contained herein and the performance of those promises, the parties agree as follows:

- 1. Upon execution of this Agreement, Successor Declarant shall be and hereby is substituted in the place of Declarant for all purposes under the Condominium Documents, and Successor Declarant hereby acquires all the rights and assumes all the responsibilities of Declarant in the Condominium, as if Successor Declarant had been the Declarant in the Condominium Documents.
- 2. Successor Declarant shall indemnify and hold Declarant harmless from all claims, demands, damages, actions, causes of action and suits of any kind or nature whatsoever which may result from Declarant executing the Condominium Documents or heretofore acting as Declarant.
- 3. This Agreement may be specifically enforced in the Superior Court for Skagit County, Washington, and the prevailing party in any such enforcement action shall recover its reasonable attorney fees and costs.
- 4. This Agreement shall be recorded with the Skagit County Auditor as notice to all who deal with the Units in the Condominium that Declarant is no longer acting as Declarant and Declarant has no further rights or responsibilities in connection with the Condominium. Anyone seeking to deal with the Units and Common Areas in the Condominium after this date shall deal with Successor Declarant.
- 5. This Agreement shall be binding upon and shall inure to the benefit of the parties hereto, their heirs, successors and assigns.


