This amendment to the stumpage agreements known as Red Rover, Stumpage Agreement, Dated 30 Sept 98; Sygnificantly Different, Stumpage Agreement, Dated 17 June 99; and, Silviculture Thin, Thinning Stumpage Agreement, Dated 22 June 99, between Crown Pacific Limited Partnership, a Delaware limited partnership ("Crown Pacific") and Woodland Services, Inc., a Washington corporation ("Woodland Services") is dated this _______ Of June, 2000:

Recitals

- 1. Crown Pacific and Woodland Services are parties to the agreements set forth above. Pursuant to each of these agreements set forth above, Crown Pacific has agreed to sell and Woodland Services has agreed to purchase the standing timber located variously in Whatcom, Skagit and Snohomish Counties in Washington State.
- 2. In each of these agreements, Crown Pacific has promised to provide such roads and permits as may be necessary to harvest the timber. Through no fault attributable to Woodland Services, Crown Pacific has not completed the negotiation of rights of way, the construction of the roads, and securing of permits.
- 3. The parties wish to effect these agreements in light of the delays occasioned by the lack of roads and rights of way.

Agreement

Now therefore, the parties agree:

- 1. That for each of the three agreements set forth above there shall be an "Effective Date." That date shall be unique to each agreement and shall be defined as the date upon which Crown Pacific shall:
 - a. provide to Woodland Services such permits as are necessary to harvest the timber described in the agreement in question, and

- b. certify to Woodland Services that the roads necessary to harvest the timber are in place and are in a condition suitable for the transportation of equipment and timber appropriate for the timber. Suitable in this context shall mean that the roads are built to at least the better of the standards of the industry or the standards imposed by appropriate federal, state or local laws, including such standards as may be imposed by environmental regulations.
- 2. The termination date in each agreement as defined by that agreement shall be changed to the first anniversary of the effective date of the agreement as that term is defined above.
- 3. Any interest and any obligation to pay accruing under the agreement on any payments set forth within the agreement as owed between the parties shall not accrue nor shall it be due until the effective date of the agreement as the parties have defined that term above.
- 4. The parties do not modify any term of any of the agreements not set out herein. The unamended portion of the each of the agreements remains in full force and effect.
