JUDGMENT

Based upon the Findings of Fact and Conclusions of Law, dated August 11, 2000; now, therefore, IT IS ORDERED:

1. Plaintiff is awarded judgment on its claim for amounts due, the principal amount of \$79,652.34 plus interest through July 31, 2000 in the amount of \$27,597.24, plus interest from August 1, 2000 through the date of entry of this Judgment calculated at the rate of \$15.44 per day plus interest calculated at the rate of 1 1/2 % per month on the amount of \$46,684.90 commencing August 1, 2000 on the increasing balance, which altogether totals interest in the amount of \$28,020.28;

2. As the prevailing party herein, Plaintiff is awarded the amount of \$20,527.50 for attorney's fees, and \$223.00 for costs and expenses, for a total amount of \$20,750.50;

3. Final judgment in this matter shall bear interest at the following rates: \$46,938.15 of the final judgment shall bear interest at the rate of 1 1/2 % per month on the increasing balance, and the remainder of the final judgment in the amount of \$81,484.97 shall bear interest at of 1 % per month on the principal balance, all until paid in full.

4. Plaintiff is entitled to all reasonable and necessary attorney's fees, costs and expenses incurred in collecting this Judgment.
