INGRESS, EGRESS, AND COST-SHARING AGREEMENT FOR WELLPUMP, WATER TOWER, AND WATERLINE

RECITALS

- 1. Grantor is the owner of the real property located in Skagit County legally described as follows: Lot 4 of Stoffer's Addition, Sinclair Island, as recorded in Volume 8 of Plats, page 69, Skagit County, State of Washington.
- 2. Grantee is the owner of the real property located in Skagit County legally described as follows: Lot 5 of Stoffer's Addition, Sinclair Island, as recorded in Volume 8 of Plats, page 69, Skagit County, State of Washington.
- 3. The wellpump, water tower, and waterline constructed on Grantor's property and a portion of Grantee's property provides water to the residence on Grantor's property and the residence on Grantee's property. Both parties desire to establish general provisions for ingress and egress rights, and the costs of maintenance and repair related to the wellpump, water tower, and waterline.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantor and Grantee agree as follows:

- 1. Grantor and Grantee hereby grant each other a non-exclusive, perpetual easement ("Easement") over, across, and under each parties' property for the express purpose of ingress and egress to, and the use of, the wellpump, water tower, and waterline. - 2. Both parties agree to share equally in the costs for maintenance and repair of the wellpump, water tower, and waterline.
