NATIVE GROWTH PROTECTION EASEMENT/BUFFER ZONE:

A Native Growth Protection Easement (NGPE) is hereby dedicated to the public for Tract "A", including a 15' easement on Lots 16, 19 and 20, measured from the wetland boundary as shown on the plat drawing for the beneficial interest in the land within the easement.
