TOGETHER WITH that portion of Tract "B", Short Plat No. 53–78, recorded in Volume 3 of Short Plats at Page 2, records of Skagit County, Washington described as follows:

The District agrees to provide a single domestic water service to the described property, under the following conditions:

- 1. The Owner, at the time of request for service, will pay a meter installation fee, a System Development Fee based on the meter size and a Charge in Lieu fee.
- 2. One meter will be permitted to serve the existing property. At the time the above described property is subdivided, creating any additional lots or a second residence is constructed on the property the Owner at the time will pay for any necessary water pipeline extensions to provide service to the new lot(s) as outlined in Resolution 1626–94 or it's successor.

- 3. The meter to 16011 Beaver Lake Road will be located near the right of way line of Beaver Lake Road and the intersection of the easement to the property.
- 4. The Owner acknowledges that precautions should be taken in instances where aquatic life may come in contact with the District's water that contains specific disinfectants such as chlorine and /or chloramine.
- 5. The Owner or the future owners agree to abide by all the rules and regulations of the District. In the event of dispute between the Owners and the District over the terms and conditions thereof, of over any claims pursuant hereto the prevailing party shall be entitled to their attorney fees and costs.
- 6. This Agreement shall remain with the land. The District shall record this Agreement with the Auditor's Office of Skagit County. At the time that the property is subdivided and the above pipeline system improvements made, the District shall withdraw the Agreement after the Owner of the property at that time have fulfilled the obligations as required by this Agreement.
