WHEREAS, concurrently herewith, by separate instrument, Successor Declarant is amending the Survey Map and Plans to revise the boundaries of certain Units;

NOW, THEREFORE, pursuant to Section 25 of the Declaration, Successor Declarant hereby amends the Declaration as follows:

- 1. Section 10.1 shall be deleted in its entirety and a new Section 10.1 shall be inserted in its place, as follows:
 - 10.1 The undivided common interest in the Common Elements and the liability for Common Expenses for each Unit shall be in equal shares, which shall be determined for each Unit by a fraction, the numerator of which is one (1) and the denominator of which is the total number of Units which are part of the Condominium.
- 2. Appendix B of the Declaration is hereby deleted in its entirety, and a new Appendix B in the form attached hereto shall be inserted in its place.
- 3. Pursuant to Article 25.3 of the Declaration, the Amendment set forth herein shall be effective upon recording.
- 4. Except as otherwise set forth herein, all provisions of the Declaration shall remain in full force and effect.
