AGAINST DEED OF TRUST**



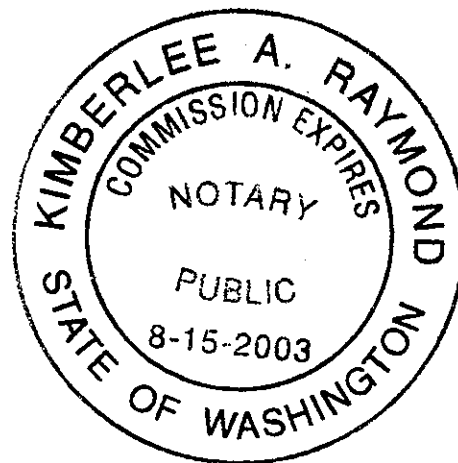
