THIS MEMORANDUM OF LEASE ("Memorandum"), made and entered into as of the <u>DIST</u> day of day of ..., 2000, by and between MT. VERNON ASSISTED LIVING INVESTORS, LLC, a Tennessee limited liability company ("Lessor"), and MT. VERNON MEDICAL INVESTORS LIMITED PARTNERSHIP, a Tennessee limited partnership ("Lessee");

#### <u>**WITNESSETH:**</u>

NOW, THEREFORE, for and in consideration of the premises, and other good and valuable considerations, the receipt and sufficiency of which are hereby acknowledged, it is agreed by the parties as follows:

- 1. Lesssor hereby leases to Lessee, and Lessee hereby leases from Lessor, for the rents described in the Lease and upon the mutual agreements and covenants and subject to the reservations, terms and conditions set forth in the Lease, the Premises known as Mt. Vernon, The Bridge, situated in Skagit County, Washington, effective as of AUGUST 31, 2000, and shall extend for the number of years from such date provided in Exhibit B, Item 1, all as more particularly set forth in the Lease.
- 2. In addition to the foregoing, Lessee shall have the option to renew the Lease for the number of consecutive terms set forth in Exhibit B, Item 2, and each option shall be for the number of years set forth in Exhibit B, Item 3, all subject to the terms and conditions set forth in the Lease.


