That portion of the South 1/2 of the South 1/2 of the Northwest 1/4 of Section 32, Township 35 North, Range 3 East, W.M., described as follows:

Beginning at the Southwest corner of said subdivision; thence North 89 degrees 07'38" East, along the South line of said subdivision, 1280 feet; thence North 1 degree 11'37" West parallel with the East line of the Southwest 1/4 of said Northwest 1/4 of Section 32, 20 feet to the North line of the County road, and the true point of beginning; thence continue North 1 degree 11'37" West 637.41 feet to the North line of the South 1/2 of the South 1/2 of the Northwest 1/4 of Section 32; thence North 89 degrees 14'39" East, along said line, 1360 feet to a point which is 18.90
