Whereas, the homeowners of Mount Baker View Condominium located at 910-34th Street, Anacortes, WA, desire to amend the document entitled, "Creation and Declaration of Condominium and of Covenants, Conditions, Restrictions and Reservations for Mount Baker View Condominiums," Article IV - Units, paragraph 4.3 Identification of Units.

Now Therefore, the undersigned hereby amend said Declaration of Condominium Article IV – Units, Paragraph 4.3 Identification of Units by adding the following for clarity:

Unit 302 contains 905 square feet, including 80 feet of deck and storage space, with two (2) bedrooms, two (2) bathrooms, a fireplace, and two (2) parking spaces in the underground garage.

Unit 303 contains 1390 square feet, including 90 feet of deck and storage space, with two (2) bedrooms, two (2) bathrooms, a fireplace, and two (2) parking spaces located in the southeast corner of the underground garage identified with the numbers 303.

All other Sections of said Declaration of Condominium are hereby reaffirmed and Article IV, Paragraph 4.3 shall be the only Article to have been deemed amended herein.
