
A UTILITY EASEMENT ACROSS ASSESSOR'S PARCEL No.P29954 TO ASSESSOR'S PARCEL No.P29956

A non-exclusive utility easement 15 feet wide over, under, and through a portion of the northeast quarter of Section 36, Township 34 North, Range 4 East, W.M. described as follows:

Commencing at the southeast corner of Parcel B described in Statutory Warranty Deed to Timothy J. McGarrah and Chikita McGarrah under Auditor's File Number 8609100047; thence \$74°52'01"W along the south line of said Parcel B, a distance of 176.62 feet to the initial point of this centerline description; thence N16°00'59"W, a distance of 71.01 feet to the north line of the south 11 feet of Parcel A described in Statutory Warranty Deed to Timothy J. McGarrah and Chikita McGarrah under Auditor's File Number 8609100047 and the terminus of this centerline description.

Situated in Skagit County, Washington.





PARCEL "A":

The East 230 feet of the North 130 feet AND the South 160 feet of the North 290 feet of that portion of the Southeast ¼ of the Northeast ¼ and of Government Lot 6, Section 36, township 34 North, Range 4 East, W.M., described as follows:

Beginning at the Southeast corner of the Northeast ¼ of said Section 36;

thence South 89°25'43" West, along the South line of said Northeast ¼, a distance of 1208.46 feet to the TRUE POINT OF BEGINNING of this description;

thence North 17°05'32" West, a distance of 930.67 feet; thence South 74°16'52" West, a distance of 508.04 feet, more or less, to a point on the East right-of-way line State Highway 1-A; thence in a Southerly direction, along said East right-of-way line of State Highway 1-A, on a curve to the right, to a point on the South line of the Northeast ¼ of said Section 36;

thence North 89°25'43" East, along said South line of the Northeast ¼, a distance of 514.21 feet, more or less, to the TRUE POINT OF BEGINNING.

PARCEL "B":

That portion of Parcel "B" described in Statutory Warranty Deed to Timothy J. McGarrah and Chikita McGarrah under Auditor's File Number 8609100047 lying in the Northeast ¼ of Section 36, Township 34 North, Range 4 East, W.M. lying Westerly of the following described line:

Beginning at the Northwest corner of said Parcel "B"; thence North 74°52'01" East along the North line of said Parcel "B", a distance of 222.69 feet to the initial point of this line description;

thence South 23°54'01" West, a distance of 77.24 feet to the South line of said Parcel "B" and terminus of this line description.
