ORDINANCE 1435

AN ORDINANCE REZONING THE ORA N. LACEY ANNEXATION FROM RESIDENTIAL IN SKAGIT COUNTY TO R-1-8.4, SINGLE FAMILY RESIDENTIAL WITH AN 8,400 SQUARE FOOT MINIMUM LOT SIZE, SITUATED IN THE COUNTY OF SKAGIT, STATE OF WASHINGTON.

WHEREAS, the property described has recently been annexed into the City of Burlington and zoning must be established following annexation, and

WHEREAS, a duly advertised public hearing to establish a zone compatible with the Comprehensive Plan for the site was held before the City of Burlington Planning Commission on May 16, 2000, at which hearing all persons appearing and desiring to be heard were duly heard, and

WHEREAS, the City Council believes that the property should be reclassified to R-1-8.4, single family residential.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BURLINGTON, WASHINGTON DO ORDAIN AS FOLLOWS:

SECTION 1. The following described property is hereby zoned R-1-8.4, single family residential:

Parcel Number P72399

Plat of First Addition to Burlington, Lot 7, Block 138 Situate in the County of Skagit, State of Washington.

SECTION 2. This ordinance shall be in full force and effect five days after its passage, approval and publication as provided by law.


