AN ORDINANCE ANNEXING TO THE CITY OF BURLINGTON A TRACT OF LAND LOCATED IN ALL THAT PORTION OF TRACT 65, "PLAT OF THE BURLINGTON ACREAGE PROPERTY", ACCORDING TO THE MAP THEREOF RECORDED IN VOLUME 1 OF PLATS, PAGE 49, RECORDS OF SKAGIT COUNTY, WASHINGTON, LYING EASTERLY OF THE FOLLOWING DESCRIBED LINE: BEGINNING AT THE NORTHWEST CORNER OF THAT CERTAIN TRACT CONVEYED TO SKAGIT COUNTY DIKE DISTRICT NO. 12. BY QUIT CLAIM DEED RECORDED UNDER SKAGIT COUNTY AUDITOR'S FILE NO. 797624, AS SAID POINT IS SHOWN ON THAT CERTAIN RECORD OF SURVEY RECORDED IN BOOK 9 OF SURVEYS AT PAGE 178 UNDER SKAGIT COUNTY AUDITOR'S FILE NO. 9004250019; THENCE NORTH 26°43'48" EAST 310.00 FEET ON THE PROJECTION OF THE WESTERLY LINE OF SAID SKAGIT COUNTY DIKE DISTRICT NO. 12 TRACT RECORDED UNDER SKAGIT COUNTY AUDITOR'S FILE NO 797624; THENCE NORTH 40°23'35" EAST 211.66 FEET TO A POINT ON THE WEST LINE OF THAT CERTAIN TRACT CONVEYED TO DIKE DISTRICT NO. 12 BY DEED RECORDED UNDER AUDITOR'S FILE NO. 528515; THENCE ALONG SAID LINE NORTH 26°43'48" EAST (CALLED NORTH 27° 16' EAST ON PREVIOUS DEED RECORDED UNDER AUDITOR'S FILE NO 528515) TO ITS INTERSECTION WITH THE NORTH LINE OF SAID TRACT 65, SAID POINT LYING SOUTH 89°45'42" WEST A DISTANCE OF 183.64 FEET FROM THE NORTHEAST CORNER OF SAID TRACT 65, AS SAID POINT IS SHOWN ON THAT CERTAIN RECORD OF SURVEY RECORDED IN BOOK 8 OF SURVEYS AT PAGE 24 UNDER SKAGIT COUNTY AUDITOR'S FILE NO. 8807190077, SAID POINT BEING ALSO THE END OF SAID DESCRIBED LINE, AND THE ABUTTING GARDNER ROAD RIGHT-OF-WAY, SITUATE IN THE COUNTY OF SKAGIT, STATE OF WASHINGTON.

WHEREAS, the City of Burlington and Dike District #12, property owners, have petitioned the City Council for annexation of the property to the City of Burlington, by petition dated June 11, 1998, and

WHEREAS, pursuant to property notice as posted and published according to law a public hearing was held on said petition on September 24, 1998 and the City Council voted to approve the annexation, and

WHEREAS, said proposed annexation was referred to the Boundary Review Board and the appeal period expired on January 16, 1999.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BURLINGTON DO ORDAIN AS FOLLOWS:

Section 1. That certain territory situated in Skagit County, Washington lying contiguous to the present boundaries of the City of Burlington and as described below is hereby annexed to the City of Burlington.

All that portion of Tract 65, "Plat of the Burlington Acreage Property", according to the map thereof recorded in Volume 1 of Plats, page 49, Records of Skagit County, Washington, lying Easterly of the following described line:

BEGINNING at the Northwest corner of that certain tract conveyed to Skagit County Dike District No. 12, by Quit Claim Deed recorded under Skagit County Auditor's File No. 797624, as said point is shown on that certain Record of Survey recorded in Book 9 of Surveys at page 178 under Skagit County Auditor's File No. 9004250019; thence North 26°43'48" East 310.00 feet on the projection of the Westerly line of said Skagit County Dike District No. 12 Tract recorded under Skagit County Auditor's File No. 797624; thence North 40°23'35" East 211.66 feet to a point on the West line of that certain tract conveyed to Dike District No. 12 by Deed recorded under Auditor's File No. 528515; thence along said line North 26°43'48" East (called North 27° 16' East on previous Deed recorded under Auditor's File No 528515) to its intersection with the North line of said Tract 65, said point lying South 89°45'42" West a distance of 183.64 feet from the Northeast corner of said Tract 65, as said point is shown on that certain Record of Survey recorded in Book 8 of Surveys at page 24 under Skagit County Auditor's File No. 8807190077, said point being also the end of said described line,

AND THE ABUTTING GARDNER ROAD RIGHT-OF-WAY,

Situate in the County of Skagit, State of Washington.

Section 2. Pursuant to the petition for Annexation the described property hereby annexed to the City of Burlington will be subject to liability for existing indebtedness of the City of Burlington.

Section 3. This ordinance shall be in full force and effect five (5) days after its passage, approval and publication as provided by law.


