
Legal description;



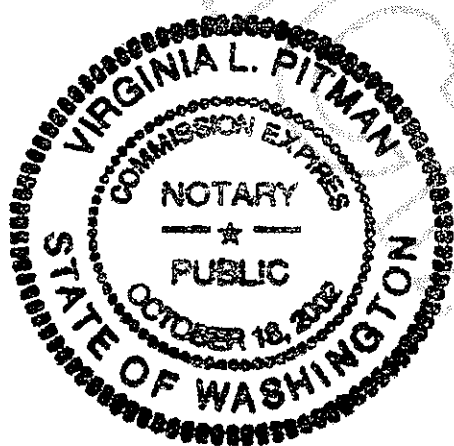

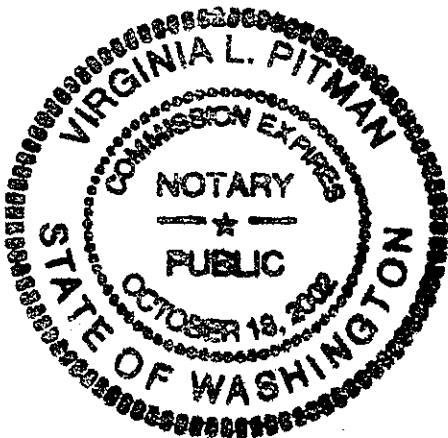
