DEEDS OF TRUST MODIFICATION AGREEMENT

THIS DEEDS OF TRUST MODIFICATION AGREEMENT ("Agreement") is made and entered into by and between UPPER SKAGIT INDIAN TRIBE, a federally recognized Indian Tribe (hereinafter referred to as "Grantor") and WELLS FARGO BANK, NATIONAL ASSOCIATION (hereinafter referred to as "Beneficiary") as agent for Lenders:

WITNESSETH:

WHEREAS, Beneficiary as Agent Bank for Lenders and Lenders and Grantor are parties to a Loan and Security Agreement dated September 18, 2000, as amended by First Amendment to Loan and Security Agreement dated December 8, 2000 (collectively, "Loan Agreement") and the execution of this Agreement is pursuant to the conditions of said Loan Agreement.

AND WHEREAS, Grantor heretofore executed and delivered a Deed of Trust, Security Agreement, Assignment of Leases and Rents and Fixture Filing by Grantor, in favor of Land Title Insurance Company of Skagit County, as Trustee, dated September 18, 2000 (hereinafter referred to as "Golf Course-Deed of Trust"), which Golf Course-Deed of Trust was recorded on the 19th day of September, 2000, as Instrument No. 200009190098 records of Skagit County, Washington, and was recorded on September 18, 2000 in records of Secretary of Upper Skagit Indian Tribe under File No. 00-0004, on certain real estate in said county and state, said Golf Course-Deed of Trust being made to secure one Note dated September 18, 2000 (hereinafter referred to as "Note"), for the aggregate principal sum of \$23,500,000 with interest and also such further sums as may be advanced or loaned by Lenders.

AND WHEREAS, Grantor heretofore executed and delivered a Leasehold Deed of Trust, Security Agreement, Assignment of Leases and Rents and Fixture Filing by Grantor, in favor of Land Title Insurance Company of Skagit County, as Trustee, dated September 18, 2000 (hereinafter referred to as "Hotel Deed of Trust"), which Hotel Deed of Trust was recorded on the 18th day of September, 2000, under Filing No. 00-0003, records of Secretary of Upper Skagit Indian Tribe in Skagit County, Washington, on certain real estate in said county and state, said Hotel Deed of Trust being made to secure the Note.

AND WHEREAS, Grantor and Beneficiary have agreed to amend the Hotel Deed of Trust and the Golf Course-Deed of Trust (collectively the "Deeds of Trust") to increase the amount of indebtedness secured by the lien of the Deeds of Trust, and said parties mutually agree to modify the Deeds of Trust as hereinafter provided;

NOW, THEREFORE, in consideration of the premises, the promises and agreements between the said parties hereinafter contained, and the mutual benefits accruing to the

- Section 4.1 of the Golf Course-Deed of Trust is hereby amended to change "\$23,500,000" to "<u>\$24,400,000</u>."
- Section 4.1 of the Hotel Deed of Trust is hereby amended to change "\$23,500,000" to "<u>\$24,400,000</u>."
- This Agreement may be executed in several counterparts, each of which shall be an original and all of which shall constitute one and the same instrument.
- 4. That, except insofar as herein expressly changed, all terms, covenants and provisions of said Deeds of Trust and the obligations evidenced and secured thereby shall remain in full force and effect and are hereby expressly ratified and confirmed by the parties hereto.


