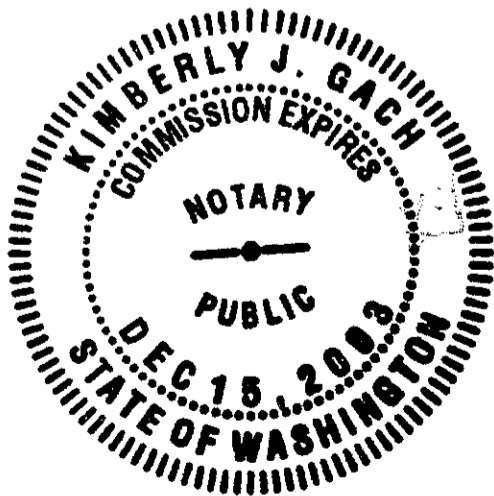

A. EASEMENT, INCLUDING TERMS AND CONDITIONS THEREOF:

Grantee: Puget Sound Power & Light Company,
a Washington corporation
Purpose: The right to construct, operate, maintain,
repair, replace and enlarge an underground
electric transmission and/or distribution
system
Area Affected: A strip of land 10 feet in width across
all lots, tracts and spaces located within
the above described property being
parallel to and coincident with the
boundaries of all private/public street
and road right of way.
Recorded: December 9, 1991

B. Conditions contained in the Dedication of said Plat, as follows:

"...dedicates to the use of the public forever, the streets and
avenues shown hereon and the use thereof for all public purposes
consistent with the use thereof for public highway purposes together
with the right to make all necessary slope for cuts and fills upon
the lots and blocks shown hereon in the original reasonable grading
of all such streets and avenues shown hereon."

C. Notes contained on the face of the Plat, as follows:

This Plat is located within the floodplain of the Skagit River
(Flood Zone A01). Finished floor elevation may have to be elevated
to comply with floodplain requirements. See City of Mount Vernon
Building Officials for details.

D. Sewer Assessment Credit contained on the face of the Plat, as
follows:

Each lot in this plat shall receive a one time credit in the
amount of \$900.00 against the sewer capacity charge. This credit
shall be given at the time of sewer permit issuance.

E. Easement provisions contained on the face of the Plat, as
follows:

An easement is hereby reserved for and granted to City of Mount
Vernon, Public Utility District No. 1, Puget Sound Power and Light
Company, G.T.E., Cascade Natural Gas Corp., and TCI Cablevision of
Washington, Inc., and their respective successors and assigns under

E. (Continued:)

and upon the exterior seven (7) feet of front boundary lines of all lots and tracts and other utility easements shown on the face of the plat, in which to install, lay, construct, renew, operate, maintain and remove utility systems, line, fixtures, and appurtenances attached thereto, for the purpose of providing utility service to the subdivision and other property, together with the right to enter upon the lots and tracts at all times for the purposes stated, with the understanding that any grantee shall be responsible for all unnecessary damage it causes to any real property owner in the subdivision by the exercise of rights and privileges herein granted.

F. Private Drainage Easement contained on the face of the Plat, as follows:

An easement for the purpose of conveying local storm water runoff is hereby granted in favor of all abutting lot owners in the areas designated as private drainage easements. The maintenance of private drainage easements established and granted herein shall be the responsibility of, the costs thereof shall be borne equally by, the present and future owners of the abutting property and their heirs, personal representatives, and assigns.

The City of Mount Vernon is hereby granted the right to enter said easements for emergency purposes at its own discretion.

G. Note regarding Tract A as shown on the face of the Plat, as follows:

A strip of land to be conveyed to the City of Mount Vernon to be used for ingress and egress to Lot 19 and for utilities and pedestrian access to West Street. Lot 19 is to have full landscaping privileges of said strip upon approval by the City of Mount Vernon. No vehicular access is allowed to West Street from said strip.
