A portion of the Northwest Quarter of the Northeast Quarter of the Southwest Quarter of Section 30, Township 35 North, Range 2 East, W.M., being more particularly described as follows:

Beginning at a point on the North line of said subdivision lying 479.7 feet East of the Northwest corner thereof, said point being the Northwest corner of a parcel conveyed to Michael Bemis by Statutory Warranty Deed recorded under Auditor's File No. 8810050064; thence South 100.00 feet to the Southwest corner of said Bemis parcel;
