# PARCEL "A":

Tract 9, Plate 9, Anacortes Tidelands of Section 18, Township 35 North, Range 2 East, W.M., as per plat recorded and on file in the office of the State Land Commissioner at Olympia, Washington.

# PARCEL "B":

Beginning at the Northeast corner of Lot 13, Block 284, "MAP OF THE CITY OF ANACORTES, SKAGIT COUNTY, WASHINGTON", as per plat recorded in Volume 2 of Plats, page 4, records of Skagit County, Washington;
