> A Native Growth Protection Easement (NGPE) is hereby dedicated to the public for Tract "A", including a 15' easement on lots 16, 19 and 20 measured from the wetland boundary as shown on the plat drawing for the beneficial interest in the land within the easement. This interest includes the preservation of a native vegetation for all purposes that benefit the public health, safety and welfare, including control of the surface water and erosion, maintenance of slope stability,

> visual and rural buffering, and protection of plant and animal habitat. The NGPE imposes upon all present and future owners and occupiers of the land subject to the easement obligation, enforceable on behalf of the public by the City of Anacortes, to leave undisturbed all trees and other vegetation within the easement. The vegetation within the easement may not be cut, pruned, covered by fill, removed of damaged without express permission from the City of Anacortes, which permission must be obtained in writing from the City of Anacortes Planning Department.

> The above tracts contain storm water conveyance systems and may require maintenance and/or repair by the City of Anacortes.
