ORDINANCE 1434

AN ORDINANCE ANNEXING TO THE CITY OF BURLINGTON A TRACT OF LAND LOCATED IN THE PLAT OF FIRST ADDITION OF BURLINGTON LOT 7, BLOCK 138 ACCORDING TO THE MAP THEREOF RECORDED, AND CONSISTING OF PARCEL NUMBER P72399, ALL SITUATE IN THE COUNTY OF SKAGIT, STATE OF WASHINGTON.

WHEREAS, Ora N. Lacey, property owner, represented by James A. Lacey, Power of Attorney, has petitioned the City Council for annexation of the property to the City of Burlington, by petition dated December 1, 1999, and

WHEREAS, pursuant to property notice as posted and published according to law a public hearing was held on said petition on May 11, 2000 and the City Council voted to approve the annexation, and

WHEREAS, said proposed annexation was referred to the Boundary Review Board and the appeal period expired on September 1, 2000.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BURLINGTON DO ORDAIN AS FOLLOWS:

Section 1. That certain territory situated in Skagit County, Washington lying contiguous to the present boundaries of the City of Burlington is hereby annexed to the City of Burlington, being more particularly described as follows:

Parcel Number P72399

Plat of First Addition to Burlington, Lot 7, Block 138

AND the abutting right-of-way on North Skagit Street

Situate in the County of Skagit, State of Washington.

Section 2. Pursuant to the petition for Annexation the described property hereby annexed to the City of Burlington will be subject to liability for existing indebtedness of the City of Burlington.

Section 3. This ordinance shall be in full force and effect five (5) days after its passage, approval and publication as provided by law.


