- A. State of Washington, acting by and through the Department of Natural Resources (hereinafter referred to as "State"), wishes to purchase lots 7-10 of Plat 127-78 as recorded on March 20, 1979 in Volume 3 of Short Plats, Page 83, under Auditor's File No. 7903200011, records of Skagit County, State of Washington.
- B. State does not wish to purchase said lots until it has received additional protection under and clarification of the terms of the easement.
- C. Grantee under the easement wishes to encourage the State to purchase lots 7-10 and is willing to modify the terms of the easement as it affects lot 7 as requested by State as set forth hereafter.

Agreement

For and in consideration of mutual benefits, receipt of which is hereby acknowledged, the parties agree as follows:

- 1. Sections 3(d) maintenance and 3(e) indemnification are added:
 - 3(d) <u>Maintenance and improvements</u>. Grantee shall have sole responsibility for maintaining the Easement Area. The cost of improvements shall be at the sole cost of the improver unless the parties agree to share the cost.
 - 3(e) <u>Indemnification</u>. Grantee hereby agrees to indemnify, defend, and hold harmless the State, its officers and employees for any and all claims for injuries and/or damage to persons or property suffered or alleged to be suffered on or about the Easement Area by reason of the acts or omissions of the Grantee, its agents, employees, and contractors while operating under this easement.
- 2. This agreement may be signed in counterpart.


