### **RECITALS**

<u>PARTIES</u>. The parties to this reciprocal grant of easements are:

THE HENDRICKSON FAMILY TRUST, dated August 2, 1995, WILLARD MATTHEW HENDRICKSON and IDA MAY HENDRICKSON, TRUSTORS and/or TRUSTEES, hereafter referred to as "Hendrickson," and,

JOSEPH W. ENGBERG and KHIRSTIE A. ENGBERG, husband and wife, hereafter referred to as "Engberg."

#### PROPERTY.

Hendricksons are owners of property fully described on EXHIBIT A, which is attached hereto and by this reference incorporated herein, hereafter described as "the Hendrickson property."

Engbergs are owners of property fully described on EXHIBIT B, which is attached hereto and by this reference incorporated herein, hereafter described as "the Engberg property."

#### PURPOSE.

By this instrument, Hendricksons want to grant an easement to Engbergs for ingress, egress and utilities through a 20 foot strip of the Hendrickson property; and the Engbergs want to grant an easement to the Hendricksons for general use and landscaping in a 10 foot strip of the Engberg property.

ENGBERG, husband and wife, for the purpose of creating reciprocal easement rights, and for no monetary consideration, hereby grant and convey to WILLARD MATTHEW HENDRICKSON and IDA MAY HENDRICKSON, TRUSTEES of THE HENDRICKSON FAMILY TRUST, dated August 2, 1995, an easement for general use and landscaping purposes on, under and across that portion of the Engberg property described on EXHIBIT D, attached hereto and referred to as the "Hendrickson Easement Area."
