
RECITALS:

- This conveyance is made pursuant to the powers, including the power of sale, conferred upon said Trustee by that certain Deed of Trust between MICHAEL J. LANCASTER AND MICHAELINE R. LANCASTER HUSBAND AND WIFE as GRANTOR, to RHS, USDA, ACTING THROUGH THE WASHINGTON STATE DIRECTOR as TRUSTEE, and USA-ACTING AS THE RURAL HOUSING SERVICE as BENEFICIARY, dated 11/26/1985 and recorded 11/26/1985, as number 8511260081 records of SKAGIT County, Washington.
- Said Deed of Trust was executed to secure, together with other undertakings, the payment of promissory note(s) in the sum of \$ 50,500.00 with interest thereon, according to the terms thereof, in favor of USA-ACTING AS THE RURAL HOUSING SERVICE FKA FMHA OR ANY SUCCESSOR AGENCY, and to secure any other sums of money which might become due and payable under the terms of said Deed of Trust.
- The described Deed of Trust provides that the real property conveyed therein is not used principally for agricultural or farming purposes.
- Default having occurred in the obligations secured and/or covenants of the Grantor, as set forth in the Notice of Trustee's Sale described below, which by the terms of the Deed of Trust make operative the power to sell, the 30 day advance Notice of Default was transmitted to the Grantor or his successor in interest, and a copy of said Notice was posted or served in accordance with law.
- USA-ACTING AS THE RURAL HOUSING SERVICE FKA FMHA OR ANY SUCCESSOR AGENCY, being the holder of the indebtedness secured by said Deed of Trust, delivered to said Trustee a written request directing said Trustee to sell the described property in accordance with the law of said Deed of Trust.

- 6. The defaults specified in the Notice of Default not having been cured, the Trustee, according to the terms of said Deed of Trust, executed, and on 01/22/2001, recorded in the office of the auditor of SKAGIT County, Washington, a Notice of Trustee's Sale of said property as Number 2001-01220087.
- 7. The Trustee, in its aforesaid "Notice of Trustee's Sale", fixed the place of sale as SKAGIT CO CRTHOUSE, INSIDE MAIN LOBBY, 205 W. KINCAID ST, MT VERNON, WA a public place, at 10 : 00 AM and in accordance with law caused copies of the statutory "Notice of Trustee's Sale" to be transmitted by mail to all persons entitled thereto and either posted or served prior to 90 days before the sale; further, the Trustee caused a copy of said "Notice of Trustee's Sale" to be published once between the thirty-second and twenty-eighth day before the date of sale, and once between the eleventh and seventh day before the date of sale; and further, included with this notice, which was transmitted to or served upon the Grantor or his successor in interest, a "Notice of Foreclosure" in statutory form to which copies of the Grantor's Note and Deed of Trust were attached.
- 8. During foreclosure, no action was pending on an obligation secured by said Deed of Trust.
- 9. All legal requirements and all provisions of said Deed of Trust have been complied with, as to acts to be performed and notices to be given, as provided in Chapter 61.24 RCW.
- 10. The defaults specified in the "Notice of Trustee's Sale" not having been cured eleven days prior to the date of Trustee's sale and said obligation secured by said Deed of Trust remaining unpaid on APRIL 27, 2001, the date of sale, which was not less than 190 days from the date of default in the obligation secured, the Trustee then and there sold at public auction to said Grantee, the highest bidder therefore, the property herein described for the sum of \$ 115,725.00 (by the satisfaction in full of the obligation then secured by said Deed of Trust, together with all fees, costs and expenses as provided by statute).


