(Multi-Flow warranty period begins the day the unit is installed. This date starts the two-year Warranty and Maintenance coverage of the Multi-Flow System.)	
The purpose of this contract is to insure continued service and operation the Multi-Flow System installed at	
The Multi-Flow System employs the aerobic digestion and filtration process. This process involves a natural biological breakdown of wastewater organic matter and may include disinfecting. Semi-annual service inspections for the first two years of system operation are provided by the local Multi-Flow distributor and are included in the original purchase price of the Multi-Flow System. During an inspection each mechanical aerator, and other components, are serviced as outlined in the Multi-Flow Service Contract along with a visual assessment of effluent for color, turbidity and scum overflow. In the event of an improper system function determined during the inspection which cannot be remedied during the time of inspection, the owner shall be notified in writing stating the problem and estimated dated of correction. The disinfecting system (if needed) is checked and refilled, as needed, at no extra cost during the semi-annual inspections. After the initial two-year service program is completed, the Multi-Flow distributor will provide a continued service contract renewable on an annual basis. The price for continued service will not exceed 10% per annual contract renewal.	
Note that there must be a perpetual maintenance contract between the user and the service-company as long as the Multi-Flow System is in use. Systems without service contracts are and will be considered systems in failure	
This maintenance agreement is for the Multi-Flow System only and does not include any portion of the customer's wiring, plumbing, pump chambers, or disposal system.
