For and in consideration of One Dollar (\$1.00) and other valuable consideration in hand paid, HANS WISLER and CLARA WISLER, husband and wife ("Grantor" herein), hereby conveys and warrants to PUGET SOUND ENERGY, INC., a Washington Corporation ("Grantee" herein), for the purposes hereinafter set forth, a nonexclusive perpetual easement over, under, along across and through the following described real property ("Property" herein) in Skagit County, Washington:

THAT PORTION OF THE EAST HALF OF THE SOUTHEAST QUARTER OF THE NORTHWEST QUARTER OF SECTION 9, TOWNSHIP 34 NORTH, RANGE 4 EAST, W.M. LYING SOUTHERLY OF THE MOUNT VERNON-CLEAR LAKE ROAD AND NORTHERLY OF THE FOLLOWING DESCRIBED LINE:

BEGINNING AT A POINT 329 FEET SOUTH OF THE INTERSECTION OF THE SAID EAST LINE OF SUBDIVISION AND THE SOUTHERLY LINE OF THE MOUNT VERNON-CLEAR LAND ROAD; THENCE RUN IN A STRAIGHT LINE TO A POINT ON THE SOUTHERLY LINE OF ROAD WHICH IS 53.5 FEET NORTHEASTERLY ALONG SAID ROAD FROM A FOUND OF SOUTHERLY LINE WHICH IS NORTH 89° 4′ 40″ WEST OF THE POINT OF COMMENCEMENT OF SAID LINE

EXCEPT THAT PORTION GRANTED TO THE CITY OF MOUNT VERNON ROAD RIGHT-OF-WAY FOR THE IMPROVEMENT OF FRANCIS ROAD.

SITUATE IN THE COUNTY OF SKAGIT, STATE OF WASHINGTON.

Except as may be otherwise set forth herein Grantee's rights shall be exercised upon that portion of the Property ("Easement Area" herein) described as follows:

A RIGHT OF WAY FIVE (5) FEET IN WIDTH WITH TWO AND A HALF (2 1/2) FEET ON EACH SIDE OF A CENTERLINE DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT ON THE NORTHWESTERLY MARGIN OF THE ABOVE DESCRIBED PROPERTY THAT IS 50 FEET NORTHEASTERLY OF THE SOUTHWEST CORNER THEREOF, SAID POINT BEING ON THE SOUTHEASTERLY MARGIN OF FRANCIS ROAD; THENCE SOUTH 48° EAST 15 FEET TO THE TERMINUS.

- 1. Purpose. Grantee shall have the right to construct, maintain, repair, replace, improve, remove, enlarge and use the Easement Area for one or more guy wires, anchor poles and anchors together with any and all necessary or convenient appurtenances thereto. Grantee shall have the right of access to the Easement Area over and across the Property to enable Grantee to exercise its rights hereunder. Grantee shall compensate Grantor for any damage to the Property caused by the exercise of such right of access by Grantee.
- 2. Grantor's Use of Easement Area. Grantor reserves the right to use the Easement Area for any purpose not inconsistent with the rights herein granted, provided, that Grantor shall not construct or maintain any building or other structure on the Easement Area.
- 3. Successors and Assigns. Grantee shall have the right to assign, apportion or otherwise transfer any or all of its rights, benefits, privileges and interests arising in and under this easement. Without limiting the generality of the foregoing, the rights and obligations of the parties shall inure to the benefit of and be binding upon their respective successors and assigns.
