TEMPORARY CONSTRUCTION EASEMENT AND AGREEMENT

The Grantors, their successors and assigns, shall have the right to use said property in any way and for any purpose not inconsistent with the rights herein granted.

To the extent allowed by law, Grantee agrees to indemnify Grantors from and against any and all claims, demands, suits, damages, or loss, or liability arising from

Grantee's exercise of the rights granted herein except for such claims, demands, loss or liability arising out of the negligence of Grantors, or Grantors' employees or agents.

This temporary construction easement shall be binding on the parties, their successors, and assigns, in full force and effect until the Project is constructed and accepted as complete by Grantee, or upon the expiration of two years from the date of this instrument, whichever event occurs first, PROVIDED THAT Grantee, in its sole discretion, may extend this easement for three additional one-year periods.

At Grantor's request, Grantee shall execute a release of easement in a standard form, upon the completion of the Project or upon the termination of this easement and any extensions thereto as provided for herein.
