This agreement amends that certain easement recorded under Auditor's File No. 200004050002 and amended under Auditor's File No. 200102150131, records of Skagit County, State of Washington (hereinafter referred to as "Easement").

Recitals

- A. State of Washington, acting by and through the Department of Natural Resources (hereinafter referred to as "State"), wishes to purchase certain real property located in Skagit County, Washington, the legal description of which is set forth on Exhibit "A" attached hereto (hereinafter referred to as "Property") and incorporated by this reference herein. The Easement is appurtenant to the Property in addition to other parcels identified in Exhibit E to the Easement.
- B. State does not anticipate a need to use the Highland Road as described in Auditor's File No. 200004050002 to access the Property and therefore does not wish to be subject to the obligations for maintenance and indemnification imposed on the Grantee under the easement.
- C. Grantor and Grantee under the easement wish to encourage the State to purchase the Property and are willing to modify the terms of the easement as it affects the Property by releasing the State from obligations as set forth hereafter.

Agreement

For and in consideration of mutual benefits, receipt of which is hereby acknowledged, the parties agree as follows:

- 1. State, as owner of the Property or any portion thereof, is hereby released from the indemnification and liability insurance obligation under section 3(e). State is hereby released from the maintenance obligations imposed under section 3(f) for any period in which the State does not use the Highland Road or limits its use to foot traffic. During periods when the State uses this road to access the Property, the State shall share in the maintenance cost of the road in proportion to the State's use.
 - 2. This agreement may be signed in counterpart.
 - This agreement shall become effective upon transfer of any portion of the Property to the State.

- This agreement shall apply to any future acquisitions by the State of Grantor's or Grantee's property encumbered or served by the easement recorded under Auditor's File No. 200004050002.
- If any portion of this Agreement shall be invalid, void or illegal, it shall in no way affect, impair or invalidate any of the other provisions hereof.


