The undersigned subordinator and owner agrees as follows:

- 1. Judith Ann Wolf, referred to herein as "subordinator," is the owner and holder of a mortgage/deed of trust dated July 25, 2001, which is recorded under Recording No. 200107250115, records of Skagit County.
- 2. Whidbey Island Bank, referred to herein as "lender." Is the owner and holder of a mortgage/deed of trust not to exceed the amount of \$108,489.74, dated August 27, 2001, executed by James Eldon Massingale, (which is recorded in volume of Mortgages, page under auditor's file No. 20010 \$300 \(\sqrt{50} \) records of Skagit County) (which is to be recorded concurrently herewith).
