WHEREAS, Owner has executed, or is about to execute, a Deed of Trust and Note in the sum of \$177,000.00, dated August 31, 2001 \*\*, in favor of Washington Mutual Bank, hereinafter referred to as "Lender," payable with interest and upon the terms and conditions described therein, which Deed of Trust is to be recorded concurrently herewith; and

WHEREAS, it is a condition precedent to obtaining said loan that said Deed of Trust last above mentioned shall unconditionally be and remain at all times a lien or charge upon the land hereinbefore described, prior and superior to the lien or charge of the deed of trust first above mentioned; and
