That portion of Lots 1 and 2, of Short Plat No. 91-070, approved February 11, 1994 and filed in Volume 11 of Short Plats, page 60, recorded February 11, 1994, under Auditor's File No. 9402110126, being a portion of the Southwest ¼ of the Southeast ¼ of Section 8, Township 35 North, Range 8 East, W.M., lying Southerly of the following described line:

Beginning at the Southeast corner of said Lot 2; thence North 00°26′59" West along the East line of said Lot 2, a distance of 253.37 feet to the true point of beginning; thence South 88°21′53" West, a distance of 313.60 feet to the midpoint of the West line of said Lot 2; thence continuing South 88°21′53" West a distance of 292.80 feet to a point along the West line of said Lot 1 which is 293.71 feet South of the Northwest corner of said Lot 1, said point being the terminus of this line description.
