

EXHIBIT "A"

"TOGETHER WITH a non-exclusive easement for ingress and egress, roadway and utilities, over, under and across a tract of land 60 feet in width lying 30 feet on each side of the following described centerline, all being in the Southwest 1/4 of Section 28, Township 34 North, Range 4 East, W.M., the centerline of said tract being more particularly described as follows:

Commencing at a concrete monument at the intersection of Crosby Drive and Cedar Hills Drive, as shown on the Plat of Cedar Hills No. 3, as recorded in Volume 9 of Plats, at pages 36 and 37, records of Skagit County, Washington; thence South 1 degree 17'17" West along the centerline of Cedar Hill Drive a distance of 150.11 feet to the South line of said Plat, being also the true point of beginning; thence continue South 1 degree 17'17" West, a distance of 49.89 feet to the beginning of a curve to the right; thence along the arc of said curve having a radius of 875.00 feet through a central angle of 14 degrees 59'43", an arc distance of 229.00 feet to a point of compound curvature to the right; thence along the arc of said curve to the right having a radius of 325.00 feet through a central angle of 57 degrees 08'00", an arc distance of 324.08 feet to the point of reverse curvature to the left; thence along the arc of said curve to the left having a radius of 452.76 feet through a central angle of 43 degrees 08'22", an arc distance of 340.90 feet to the Northeast corner of the Southwest 1/4 of the Southwest 1/4 of the Southwest 1/4 of said Section 28, said Northeast corner being the terminus of said centerline;

EXCEPT that portion thereof lying Southerly of the North line of the South 20 acres of the Southwest 1/4 of the Southwest 1/4 of said Section 28.
