WHEREAS: Erickson is the owner of the following described property:

Lot 31, "PLATOF TINAS COMA", as per plat recorded on August 11, 2000, under Auditor's File No. 200008110004, records of Skagit County, Washington.

WHEREAS: Investors are owners of the following described property:

Lots 37 and 38, "PLATOF TINAS COMA", as per plat recorded on August 11, 2000, under Auditor's File No. 200008110004, records of Skagit County, Washington.

and,

WHEREAS: The face of the plat indicates there is an easement for access over the Easterly 10 feet of a portion of said Lot 31 which is beneficial to said Lots 37 and 38, and

**WHEREAS:** It has been determined between Erickson and Investors that the easement is no longer needed for said purpose.

NOW, THEREFORE: For valuable consideration which shall benefit all parties hereto, receipt of which is hereby acknowledged, Erickson and Investors hereby abandon, eliminate, extinguish and forever remove that portion of the 10 foot access easement shown on the face of the PLATOF TINAS COMA, and is more particularly described as follows:

That portion of Lot 31, "PLATOF TINAS COMA", as per plat recorded on August 11, 2000, under Auditor's File No. 200008110004, records of Skagit County, Washington, more particularly described as follows:

Beginning at a point on the East line of said Lot 31 which is South 00 °41'37" West a distance of from the Northeast corner thereof;

thence South 12 °19'20" East a distance of 60.71 feet;

thence South 07 932'39" East a distance of 10 feet, more or less, to an intersection with the Southerly boundary of said easement, as shown on the face of the plat;

thence South 68 °54'10" West a distance of 10 feet, more or less, to an intersection with the Westerly boundary of said easement, as shown on the face of said plat;

thence North 12°19'20" West to a point which is South 68°54'10" West of the point of beginning; thence North 68°54'10" East a distance of 10 feet, more or less, to the point of beginning.
