Commencing at the Northwest corner of said subdivision; thence East along the North line thereof a distance of 1125.30 feet to the Southwest corner of tract described in deed filed under Skagit County Auditor's File No. 9507100155, said point being the TRUE POINT OF BEGINNING;

thence South along the Southerly projection of the West line of said tract for a distance of 15 feet;
