1. GRANTORS. The undersigned Grantors are: GEORGINE M. BERINGER, individually in her ½ undivided community property interest, and GEORGINE M.

BERINGER as the duly appointed, qualified and acting personal representative of the Estate of RALPH K. BERINGER (the "Estate"). RALPH K. BERINGER died on February 16, 2001. Grantor personal representative, GEORGINE M. BERINGER, was appointed on February 27, 2001. The appointment was made in Skagit County Superior Court under cause number 01 4 00056 0 (the "Probate Proceedings"). By Order of Solvency entered on February 27, 2001 in the Probate Proceedings, Grantor was authorized to settle the Estate without further court intervention or supervision.

2. DESCRIBED PROPERTY. Included among the property of the Estate was an undivided $\frac{1}{2}$ community property interest in the real property described as follows (the "Described Property"), in which was the community property of RALPH K. 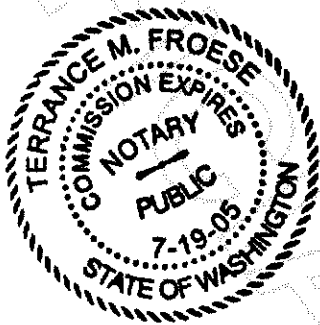
