

I.

NOTICE IS HEREBY GIVEN that the undersigned Trustee will on the 22nd day of March, 2002, at the hour of 10:00 o'clock a.m. at the Skagit County Courthouse, Third and Kincaid Streets, in the City of Mount Vernon, State of Washington, sell at public auction to the highest and best bidder, payable at the time of sale, the following described real property, situate in the County of Skagit, State of Washington, to-wit:

LOTS 6, 7, 8, and 9, Block 14, "REPLAT OF THE JUNCTION ADDITION TO SEDRO", as per plat recorded in Volume 3 of Plats, page 48, records of Skagit County, Washington.

which is subject to that certain Deed of Trust dated November 7, 1996, recorded November 13, 1996, under Auditor's File No. 9611130044, records of Skagit County Washington, from Tracy E. Drummond, a single man as Grantor(s) to Island Title Company, as Trustee, which Trustee has been succeeded by DAVID L. DAY to secure an obligation in favor of Donald M. Jagger. Subsequently, an Assumption Agreement was signed by Lynne Childs on July 20, 1998, recorded on July 24, 1998, under Auditor's File No. 9807240002, records of Skagit County.

II.

No action is now pending to seek satisfaction of the obligation in any Court by reason of the Grantor's default on the obligation secured by said Deed of Trust.

Ш.

The default for which this foreclosure is made is as follows:

Failure to pay when due the following amounts which are now in arrears: \$7,678.00 plus other charges, costs and fees as set forth in the Notice of Default, and for other than payment of money such as failure to keep property free of liens and judgments.

IV.

The sum owing on the obligation secured by the Deed of Trust is: Principal \$85,526.83 together with interest as provided in the note or other instrument secured from the 5th day of January 2001, and such other costs and fees as are due under the note or other instrument secured, and as provided by statute.

V

The above-described real property will be sold to satisfy the expense of sale and the

obligation secured by said Deed of Trust as provided by statute. Said sale will be made without warranty, express or implied, regarding title, possession, or encumbrances on the 22nd day of March, 2002. The defaults referred to in paragraph III must be cured by the 11th day of March, 2002 (11 days before the sale date) to cause a discontinuance of the sale. The sale will be discontinued and terminated if at any time before the 11th day of March, 2002 (11 days before the sale date), the default as set forth in paragraph III is cured and the Trustee's fees and costs are paid. The sale may be terminated by the Grantor anytime after the 11th day of March, 2002 (11 days before the sale date), and before the sale by the Grantor or his successor in interest or the holder of any recorded junior lien or encumbrance paying the entire principal and interest secured by the Deed of Trust, plus costs, fees, and advances, if any, made pursuant to the terms of the obligation and/or Deed of Trust, and curing all other defaults.

VI.

A written Notice of Default was transmitted by the Beneficiary or Trustee to the Grantor or his successor in interest at the following address: 819 Haines Street, Sedro-Woolley, Washington 98284, by both first class and certified mail on the 25th day of October, 2001, proof of which is in the possession of the Trustee; and the Grantor or his successor in interest was personally served on the 31st day of October, 2001 with said written notice of default or the written notice of default was posted in a conspicuous place on the real property described in paragraph I above, and the Trustee has possession of proof of such service or posting.

VII.

The Trustee whose name and address is set forth below will provide in writing to anyone requesting it, a statement of all costs and fees due at any time prior to the sale.

VIII.

The effect of the sale will be to deprive the Grantor and all those who hold by, through or under him of all their interest in the above-described property.

IX.

Anyone having any objection to the sale on any grounds whatsoever will be afforded an opportunity to be heard as to those objections if they bring a lawsuit to restrain the sale pursuant to RCW 61.24.130. Failure to bring such a lawsuit may result in a waiver of any proper grounds for invalidating the Trustee's Sale.

X.

The purchaser at the trustee's sale is entitled to possession of the property on the 20th day following the sale, as against the grantor under the deed of trust (the owner) and anyone having an interest junior to the deed of trust, including occupants and tenants. After the 20th day following the sale the purchaser has the right to evict occupants and tenants by summary proceedings under the unlawful detainer act, chapter 59.12 RCW.
