I also hereby assign to Lender any existing and future leases and rents from the property as additional security for the debt described below. I agree that I will be legally bound by all the terms stated in this Deed of Trust. The above real property is not used principally for agricultural or farming purposes.

- 9. SATISFACTION OF DEED OF TRUST.
