Vernon, State of Washington, sell at public auction to the highest and best bidder, payable at the time of sale, the following described real property, situated in the County of SKAGIT, State of Washington, to wit:

(commonly known as 23914 OLD DAY CREEK RD, SEDRO WOOLLEY, WA 98284) which is subject to that certain deed of trust dated May 5, 1995, recorded May 9, 1995, under Auditor's File No. 9505090058, records of SKAGIT County, Washington, from Brenda A. Burke, as her separate estate, as Grantor, to Island Title Company, as Trustee, to secure an obligation in favor of EquiCredit Corporation of WA, as Beneficiary, the beneficial interest in which was assigned by EquiCredit Corporation of WA to Bank of America Illinois, TR U/A dtd 05/01/95 (EQCC Home Equity Loan Trust 1995-2) under an Assignment recorded under Auditor's File No. 9507030040.

No action commenced by the Beneficiary of the Deed of Trust is now pending to seek satisfaction of the obligation in any Court by reason of the Borrower's or Grantor's default on the obligation secured by the Deed of Trust.

The sale will be made without warranty, express or implied, regarding title, possession, or encumbrances on the 25th day of January, 2002. The default(s) referred to in paragraph III must be cured by January 14, 2002 (11 days before the sale date), to cause a discontinuance of the sale. The sale will be discontinued and terminated if at any time on or before January 14, 2002 (11 days before the sale date), the default(s) as set forth in paragraph III is/are cured and the Trustee's fees and costs are paid. Failure to bring such a lawsuit may result in a waiver of any proper grounds for invalidating the Trustee's sale.


X.
