ORDINANCE 1459

AN ORDINANCE ANNEXING TO THE CITY OF BURLINGTON THAT PORTION OF TRACT 37, PLAT OF THE BURLINGTON ACREAGE PROPERTY, AND CONSISTING OF PARCEL NUMBERS P62520, P62523, P62525, THE WEST 176 FEET OF P62524 AND THE WEST 360.74 FEET OF P62521, AND ALL OF THE ABUTTING GARDNER ROAD RIGHT-OFWAY, ALL SITUATE IN THE COUNTY OF SKAGIT, STATE OF WASHINGTON.

WHEREAS, Paul G. and Diann Sager, John Bellinger. and Ronald D and Kathryn Struthers, property owners, have petitioned the City Council for annexation of the property to the City of Burlington, by petition dated February 1, 1998 and November 21, 2000, and

WHEREAS, pursuant to property notice as posted and published according to law a public hearing was held on said petition on March 8, 2001 and the City Council voted to approve the annexation, and

WHEREAS, said proposed annexation was referred to the Boundary Review Board and Skagit County invoked the jurisdiction of the Boundary Review Board who conducted a hearing on May 22, 2001, and

WHEREAS, the Resolution and Hearing decision of the Boundary Review Board was transmitted to the City on June 11, 2001.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF BURLINGTON DO ORDAIN AS FOLLOWS:

<u>Section 1</u>. That certain territory situated in Skagit County, Washington lying contiguous to the present boundaries of the City of Burlington is hereby annexed to the City of Burlington, being more particularly described as follows:

That portion of Tract 37, "PEAT OF THE BURLINGTON ACREAGE PROPERTY", as per plat recorded in Volume I of Plats, page 49, records of Skagit County and Gardner Road, described as follows:

Beginning at a point on the East line of Gardner Road 204.23 feet South of the North line of said Tract 37; thence North 89 degrees 33'24" East 118.99 feet; thence South 0 degrees 14'00" East 126.11 feet; thence South 89 degrees 32'07" East to a point 360.74 feet East of the East line of Gardner Road; thence Sough parallel with the East line of Gardner Road to the South line of said Tract 37; thence West along the South line of said Tract 37 and said South line extended West to the West line of Gardner Road; thence North along the West line of Gardner Road to a point due West of the Point of Beginning; thence East to the Point of Beginning.

Situate in the County of Skagit, State of Washington.

<u>Section 2</u>. Pursuant to the petition for Annexation the described property hereby annexed to the City of Burlington will be subject to liability for existing indebtedness of the City of Burlington.

<u>Section 3</u>. This ordinance shall be in full force and effect five (5) days after its passage, approval and publication as provided by law.


