## RECIPROCAL DURABLE POWER OF ATTORNEY

THE UNDERSIGNED SPOUSES, as principals, domiciled in the State of Washington, do hereby designate each to be the attorney-in-fact of the other, as follows:

- 1. "WHEN OPERATIVE". Pursuant to Revised Code of Washington 11.94.010-020, this Power of Attorney shall become effective upon the occurrence of the physical or mental disability, or the unexplained absence raising a doubt of the continued existence of one spouse. Disability means the inability to handle one's own affairs and must, as between the principal and the attorney-in-fact, be evidenced by the written statement of a qualified physician or an Order of Court; provided, that no person dealing with the attorney-in-fact need verify any such statement, nor the absence of the spouse, nor the propriety of the power.
- 2. "POWERS". The attorney-in-fact shall have the power to do all things with respect to the assets and liabilities of the principal, real or personal, wherever located, as the principal could do if present and competent. Further, the attorney-in-fact shall have full power to provide for the support, maintenance and health of the incompetent principal AND to provide informed consent for health care decisions on the principals behalf as provided in RCW 11.94.010 as it currently reads or as it shall in the future be amended to read.
- 3. "RELIANCE". All persons dealing with the attorney-in-fact are entitled to rely on the apparent authority of the attorney-in-fact, unless they have actual knowledge of invalidity in execution or of the revocation of this Power by death of the principal.
- 4. "EVENT". In the event both of us are disqualified from acting as an attorney-in-fact for the other by letter of a qualified physician or Court Order, or in the event one of us is deceased, we mutually and severally agree that our daughter, PATRICIA A. ROBINSON, shall act as alternate attorney-in-fact. She shall have the same powers. Those dealing with her shall be entitled to rely on her authority as if one of us was serving as attorney-in-fact for the other.
