Paragraph Labeled #1, last sentence, is to read; "The fence shall be removed for the new building.

Paragraph labeled #3 is to read; The grantors have permission to place a foundation for a single story portion of a new structure, no closer than 11.5 foot from the west boundary line of the east ½ of lot 15 (3 foot west of the west line of lot 14) The roof eaves can protrude 1.5 foot maximum to the west beyond this point. With in the easement the foundation shall be no closer to the south property line than 35 foot and no closer to the north property line than 33 foot. See Exhibit A and B Pg. 3 of this document.

The will be Grantor agrees to repair and restore any yard area disturbed by grantors construction within the subject easement.

All other terms and conditions of the original agreement remain the same and in affect as written.

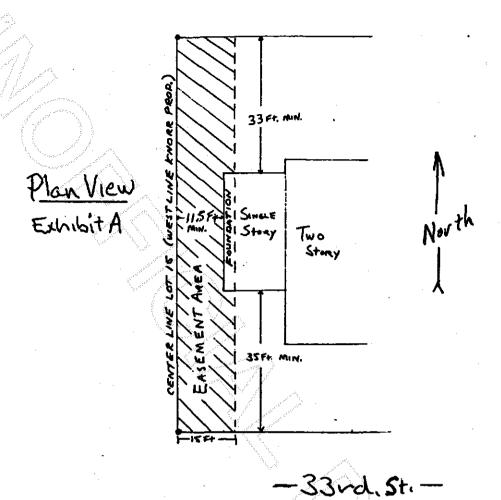

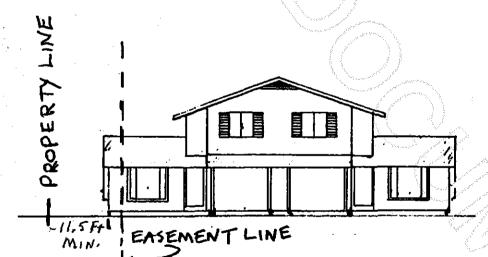
